# Public Administration (MPA)

## Postgraduate Master

### The course

This stimulating and challenging course, which is based at our Jordanstown campus, has been designed to develop the professional capacity of those working in or alongside the public sector. If your role includes management or governance, this degree will help you to develop an integrated and critically aware understanding of these two areas, thereby enhancing your effectiveness in the work place.

We expect course participants to be drawn from the public, voluntary and community sectors both locally and internationally. Administrators, managers and professionals from a wide variety of organizations are likely to find this course to be of immense benefit.

### Course structure

You will receive your Master of Public Administration (MPA) award after successful completion of taught modules and a project amounting to 180 credit points. The 9 taught modules are each worth 15 credit points. The project is worth 45 credit points.

When you start the course you will be registered as an MPA student. Students who have completed 60 or 120 credit points (4 or 8 modules) have the option of exiting the course with the award of Postgraduate Certificate or Diploma in Public Administration respectively.

### What we can offer you

- Modules that relate specifically to public sector policy development.
- Modules based upon staff research rated at national and international standards.
- A significant input from leading practitioners in the civil service and public services.
- Learning sessions that allow you to exchange information and network with colleagues from different work places to better understand how knowledge is being applied.
- Flexible delivery which recognises your need to fit your study around your home and working life.
- Modules which will be delivered on a block-release basis.
- A system whereby you can take individual modules as short courses and build these towards your award over a longer period of time thereby spreading the cost.

### Entry requirements

Normally a UK second class honours degree, or better, in any discipline or the equivalent of this for international students. Additionally, applicants should normally have gained at least 3 years' relevant work experience in a supervisory or managerial position.

Applicants for whom English is not the first language, must also have achieved a score of at least 6.0 in IELTS, or an equivalent recognised by the University.

## Length of course

Normally the course will be completed in two years.

## Course Content

### Core taught modules

- Public Administration & Governance
- Strategic Leadership
- Policy Analysis
- Applied Government
- Contemporary Issues in Public Policy
- Policy Evaluation
- Delivering services with NGOs
- Issues in Health & Social Care
- Research Methods

The Project in the final year will be a core part of the course and will give you an opportunity to explore a 'live' issue relating to your work situation. A supervisor will be appointed to give you guidance on the project.

Study material will be available early in the relevant semester. Teaching will be undertaken in 4 day blocks for each module (dates given below for the academic year 2019/2020). Assessment for each module will be completed before teaching for the next module commences.
