## ACADEMIC MISCONDUCT POLICY – Taught Courses and MRes (2023/24)

## 1. Policy

The University's policy is that academic misconduct, whether deliberate or unintentional, is cheating by attempting to gain an unfair academic advantage and is unacceptable. It is expected that all students are educated in correct academic practice including writing, citing and referencing, early in their careers at the University. Students should appreciate the value of honesty, should know what is expected of them and should understand the different forms of academic misconduct and their consequences.

### **Definitions of Academic Misconduct**

Academic misconduct includes acts of dishonesty, deception, and fraud through the attempts to gain an unfair academic advantage. The different forms of academic misconduct are defined below:

- Plagiarism is the act of taking or copying someone else's work and presenting it
  as if it were one's own. Plagiarism occurs when ideas, texts, theories, data, created
  artistic artefacts or other materials are presented without appropriate
  acknowledgement. This means that the person considering this work is given the
  impression they are viewing the student's own original work when it is not the case.
  Plagiarism can occur in various forms:
  - Copying where a student actively copies the responses of another student during an exam but is presenting this as their own work
  - Collusion which involves the unauthorised collaboration of students on a piece of assessment that should otherwise represent an individual effort.
  - Personation which involves someone assuming the identity of a student with the intent to deceive during a piece of assessment by completing the work on behalf of the student.
  - Contract cheating which involves a student engaging with and paying a third party to complete a piece of assessment on their behalf.
  - Covert use of Al generative tools where Al generative tools are deployed for assessment purposes without authorisation and/or appropriate acknowledgement.
  - Auto-plagiarism where a student's own previous work is re-presented without being properly referenced.

- Cheating during exams where a student uses inadmissible materials or any
  other material during an exam, other than those approved by the invigilator.
  Cheating during exams will also include the act of copying and the act of collusion
  where students signal answers to other students during an exam or share exam
  content with students after an exam with the intent for them to gain an unfair
  advantage.
- **Falsification** or fabrication involves the unauthorised creation of false information/data, or the alteration of information/data within a piece of assessment while presenting this information as genuine.

#### Student declaration

The standard coursework submission sheet for the receipting of coursework includes an explicit reference to the University's definition of academic misconduct as follows.

I declare that this is all my own work. Any material I have referred to has been accurately referenced and any contribution of Artificial Intelligence technology has been fully acknowledged. I have read the University's policy on academic misconduct and understand the different forms of academic misconduct. If it is shown that material has been falsified, plagiarised, or I have otherwise attempted to obtain an unfair advantage for myself or others, I understand that I may face sanctions in accordance with the policies and procedures of the University. A mark of zero may be awarded and the reason for that mark will be recorded on my file.

## **Coursework Submission Sheet**

The declaration of ownership is automatically generated in Blackboard Learn for esubmission of assignments. The declaration should also be used when assignments are submitted by other electronic means.

## Acknowledging the use of Al Generative Tools

Where generative artificial intelligence (AI) tools have been used for an assessment, they must be acknowledged appropriately to ensure that any output is not misconstrued as the student's own work. Before beginning any piece of assessed work, students should check that the use of AI tools is authorised, as this practice may differ across modules and courses of study.

### **Penalties**

The University's Policy provides simple, graduated Frameworks of Penalties for plagiarism relating the severity of penalties to the number of offences and gives individual, formative advice after the first offence. There are both academic and disciplinary consequences. Disciplinary penalties in taught courses and the MRes are not applied until the second offence. Offences are counted cumulatively, regardless of any change of course but do not carry over from undergraduate to postgraduate level.

The Framework of Penalties for taught programmes and the MRes follows. That for other research degrees is available from the Research Office's website.

# **Monitoring of Policy**

The efficacy of the Policy is monitored by the Learning and Teaching Committee which receives annual reports from the Faculties and the Research Degrees Committee.
